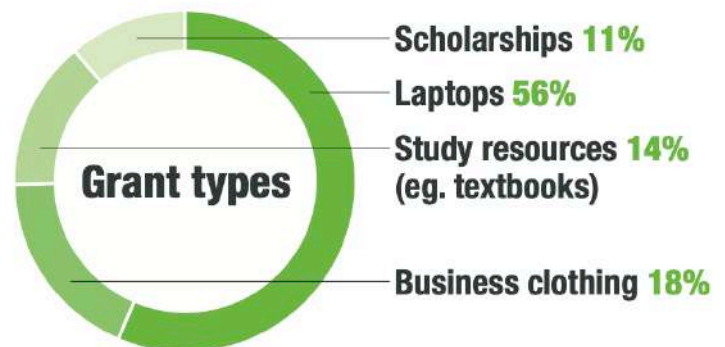
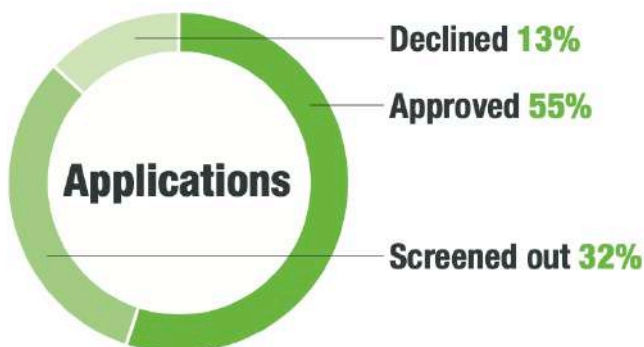
## Maysam
